## Dr. Eng. Sayed Ahmed Al-Khar ashy opened the meeting and welcomed the members of the committee with its work as follows:

- 1-The committee reviewed the various reports for the financial period ended on 30/9/2024 to identify the most important achievements that the company achieved during this period.
- -The committee reviewed the unaudited independent and consolidated financial statements of the company as of 30/9/2024 to ensure that they meet the requirements of the applicable laws and regulations, in accordance with what is stated in the Companies Law No. 159 of 1981 and its executive regulations, as well as the Capital Law No. 95 of 1992 and its executive regulations, and the disclosure requirements of the Egyptian Stock Exchange.

The review showed the following:

- The list of the independent financial statements on 30/9/2024 with a total investment of about **EGP3,882 Billion** and the total equity of about **EGP3,734billion**.
- The consolidated financial position list on 30/9/2024 with a total investment of about **EGP4,046Billion** and the total equity of about **EGP3,898 billion**.
- The independent income statement on 30/9/2024 showed the net profit for the period of about **EGP352.532Million**.
- The consolidated income statement on 30/9/2024 showed the net profit for the period of about **EGP461,923Million**.
- Statement of changes in equity and statement of cash flows, independent and consolidated, for the period ending 30/9/2024.
- Ensure that the company is committed to following the necessary procedures for the rules of registration and the continuation of listing and write-off on the Egyptian Stock Exchange.
- 2. Examination of the procedures for preparing independent business results in the independent lists for the financial period 30/9/2024, which showed the following:
- Net sales on 30/9/2024 of **EGP8,713Billion** compared to **EGP7,046Billion** on 30/9/2023.
- The cost of sales on 30/9/2024 is EGP8,141Billion compared to EGP6,351Billion on 30/9/2023
- Gross profit on 30/9/2024 of **EGP572,541Million** compared to **EGP592,313Million** on 30/9/2023.
- Examination of the procedures followed for the preparation of the financial statements on 30/9/2024, which showed a net profit of **EGP352,532Million** after income tax against a net profit of **EGP350,779 Million** on 30/9/2023

- 3. Examination of the procedures for preparing consolidated business results in the consolidated lists for the financial period 30/9/2024, which showed the following:
- Net sales on 30/9/2024 were EGP8,887Billion compared to EGP7,046Billion on 30/9/2023
- -The cost of sales on 30/9/2024 is EGP8,141Billion compared to EGP6.351Billion on 30/9/2023.
- Gross profit on 30/9/2024 is EGP746,444 Million compared to EGP695,937 Million on 30/9/2023
- Examining the procedures followed for preparing the financial statements on 30/9/2024, which showed a net profit for the period about **EGP479,079 Million**, the majority share of which is **EGP461,932 Million** after income tax in exchange for a net profit of **EGP421,470 Million** on 30/9/2023.
- 4. Ensure that the company follows the Egyptian accounting standards in preparing the financial statements for the period ending on 30/9/2024.

Considering the examination of the procedures followed in the preparation and review of the independent and unaudited consolidated financial statements of the Alexandria Mineral Oil Company (AMOC) on 30/9/2024, it was not found that there were any significant or influential amendments that should be made to those mentioned financial statements to conform to the Egyptian accounting standards.

The committee also reviewed the report on reviewing extracts and maintenance contracts, and the report on reviewing the medical care system for employees and their families and it also ensured that an independent consultant prepared a report on transactions with related parties. and according to the committee was assured the internal control system is working efficiently

At the end of the meeting, the committee recommended presenting its unaudited reports and the

independent and consolidated financial statements to the Board of Directors for approval.

Then the meeting ended at three o'clock in the evening.
